The COVID-19 pandemic continues to deeply affect the world in many ways. As cultural institutions and artistic exchanges have been hit particularly hard by the global crisis, today, more than ever, the Cultural Services of the French Embassy and the FACE Foundation are proud to encourage, promote and support artistic performances and creations.

FACE Foundation, in collaboration with the Cultural Services of the French Embassy in the U.S., is pleased to launch its call for projects supported by the 2021 Jazz & New Music program.

The Jazz & New Music program is designed to encourage the creative and professional development of French jazz and contemporary composers, musicians and ensembles in the U.S.

Jazz & New Music Program is a program of FACE Foundation and the Cultural Services of the French Embassy in the United States, with support from the Florence Gould Foundation, the French Ministry of Culture, Institut français-Paris, Bureau Export and Société des Auteurs et Compositeurs de Musique (SACEM).

PROGRAM OVERVIEW

The **Jazz & New Music** program is designed to encourage the creative and professional development of French jazz and contemporary composers, musicians and ensembles in the U.S.

The program awards three different kinds of grants:

- **Creative Grants** – supporting new creations & new commissions
- **Residency Grants** – supporting residencies of French artists in the U.S.
- **Touring Grants** – supporting tours of French artists and ensembles in the U.S.

NEW! Jazz & New Music has adjusted its criteria to better answer the needs of artistic cooperation between France and the United States in today's world **by encouraging the development of digital and hybrid (digital + in-person) projects.**

Jazz & New Music Creative Grants support projects jointly conceived by French and American professional musicians and institutions that encourage artistic exploration, foster intercultural dialogue, and contribute to the dynamism of the musical aesthetics it defends. It also supports new commissions to French composers, especially in the field of new music.

Jazz & New Music Residency Grants support French musicians and composers seeking to develop specific projects including research in collaboration with an American organization. The residency enables artists to immerse themselves in their community, and develop new contacts and networks. It also allows artists to generate new collaborative projects that may continue beyond the residency.

Jazz & New Music Touring Grants support touring projects of French musicians and ensembles with a minimum of three performances in the U.S.

FUNDING OPPORTUNITIES

The **Jazz & New Music** program awards grants through an open, competitive application process for projects taking place in the United States and/or its respective territories, involving French composers, musicians and ensembles. The program will prioritize projects including new generations of composers and emerging artists that reflect the cultural and artistic diversity of the French and American contemporary music scene. Special attention will be given to projects involving women, and projects that have the capacity to reach new audiences and engage communities through public performances.

1/ Jazz & New Music Creative Grants

The program encourages applications for projects resulting in the creation of new works. Commissions to French composers and collaborations between French and American musicians and institutions will be supported with up to 10,000 dollars. This year, special attention will be given to digital and hybrid projects.

PROJECT ELIGIBILITY

- Digital and hybrid creative projects (commission included) between French and American musicians must take place between **March 1, 2021 & August 31, 2022**.
- In-person only creative projects must take place between **September 1, 2021 & August 31, 2022**.
- Commissions may include arrangements, compositions, rehearsals, performances and recordings;
- Works presented must be composed by living composers.

Priority will be given to:

- Projects resulting in live performances;
- Projects involving artists or living composers whose work has rarely been seen in the partner country;
- Projects involving new generations of composers;
- Projects involving women artists and/or composers;
- Projects reflecting diversity and inclusion;
- Projects experimenting with new forms of music.

The fund will not support directly individual artists.

Grant Application Deadline: February 28, 2021 (Midnight - PST)

2/ Jazz & New Music Residency Grants

Residencies are intended for French artists who already have an American partner willing to support their research, facilitate the development of their artistic project, and help them develop their network. In 2021, up to four residency projects will be selected by the Jazz & New Music artistic committee. This year, special attention will be given to digital and hybrid projects.

PROJECT ELIGIBILITY

- Digital and hybrid residency projects must take place between **March 1, 2021 & August 31, 2022.**
- In-person only residency projects must take place between **September 1, 2021 & August 31, 2022.**
- Residencies may include arrangements, compositions, rehearsals, performances and recordings;
- Works presented must be composed by living composers.

Priority will be given to:

- Projects involving artists or living composers whose work has rarely been seen in the partner country;
- Projects involving new generations of composers;
- Projects involving women artists and/or composers;
- Projects reflecting diversity and inclusion;
- Projects experimenting with new forms of music.

The fund will not support:

- Individual artists directly;
- Residency projects that solely include the rental of a studio or space without a commitment from an American partner.

3/ Jazz & New Music Touring Grants

Promoting French musicians and ensembles in the U.S. is a core goal of the program. Touring projects will be supported with up to 10,000 dollars, solely for projects confirmed by an American presenting venue. This year, special attention will be given to digital and hybrid projects.

PROJECT ELIGIBILITY

- Digital and hybrid touring projects between French and American musicians must take place between **March 1, 2021 & August 31, 2022.**
- In-person only touring projects must take place between **September 1, 2021 & August 31, 2022.**
- Tours must include at least 3 shows or public programs (masterclasses are considered);
- Works presented must be composed by living composers.

Priority will be given to:

- Projects involving artists or living composers whose work has rarely been seen in the partner country;
- Projects presented in a minimum of 3 different cities;
- Projects involving new generations of composers;
- Projects involving women artists and/or composers;
- Projects reflecting diversity and inclusion;
- Projects experimenting with new forms of music.

The fund will not support directly individual artists.

Grant Application Deadline: February 28, 2021 (Midnight - PST)

WHO MAY APPLY

The **Jazz & New Music** program offers financial support in the form of grants to American or French nonprofit organizations that represent, produce, or present the project of the artist(s).

Creative Grants

- Individual artist or ensemble involved should work at a professional level;
- Individual artist or ensemble involved must be French or U.S. citizens or legal residents for the past five years and currently reside in their respective territory;
- Applicants must be (or represented by) an American nonprofit institution or a French *association loi 1901*;
- Applicants (or their representatives) must be able to demonstrate their nonprofit status.

Residency Grants

- Individual artist or ensemble involved should work at a professional level
- Individual artist or ensemble involved must be French citizens or legal residents for the past five years and currently reside in France or its territories;
- Artists involved must speak English;
- Applicants must be (or represented by) an American nonprofit institution or a French association loi 1901;
- Applicants (or their representatives) must be able to demonstrate their nonprofit status.

The partner institution – residency space, studio, live music venue, multidisciplinary art center, festival, or university – must show a clear artistic and financial commitment towards the project. Partners are committed to accompanying artists by providing advice regarding their work, facilitating access to resources and professional networks, and create opportunities for exposure (interaction with the community, with an audience etc...)

Touring Grants

- Individual artist or ensemble involved should work at a professional level;
- Individual artist or ensemble involved must be French citizens or legal residents for the past five years and currently reside in France or its territories;
- Applicants must be (or represented by) an American nonprofit institution or a French *association loi 1901*. Presenting venues can apply individually. However, it is recommended to coordinate with other venues involved in a tour before applying;
- Applicants (or their representatives) must be able to demonstrate their nonprofit status;
- Companies and ensembles may submit applications for performances and tours **only if they have obtained written engagement from presenting partners.**

ELIGIBLE EXPENSES

Funding may be used towards the following:

- Travel-related expenses (international airfare, domestic travel, accommodations, and per diem);
- Visa fees;
- Artist fees;
- Promotion & marketing;
- Production costs **related to the digital, hybrid or in-person artistic project only.**

All individuals and ensembles must obtain the required travel documentation to legally enter the United States and France. If the proposed project involves a public performance in the United States or France, artists must follow immigration law and secure the necessary work visa prior to the performance.

ADJUDICATION PROCESS

A panel composed of French and American professionals will review applications submitted for consideration and make recommendations for support. Final approval of grants is made by the Board of Directors of FACE Foundation based on panel recommendations.

REVIEW CRITERIA & NOTIFICATION

Applications are evaluated according to the following criteria:

- Excellence demonstrated by the artists' or ensembles' record of professional achievement;
- Quality of project design, creative exploration and/or plan for professional advancement;
- Capacity to successfully implement the project;
- Potential to develop performances and tours in the United States.

All applicants will be notified in writing of the panel's decision in May 2021. The decisions of the panel are final and may not be appealed.

FINAL REPORT

Final report forms are issued with the grant contract. Final reports must be submitted **no later than 30 days after the grant period end date**. Final reports require a description of work completed during the project period along with a brief accounting of expenditures, pictures and promotion materials. The second installment of the grant will be paid upon receipt of the duly completed final report.
